Enjoying a prime central location, in immediate proximity to shops, schools, bus stops, and the main attractions of Antibes and Juan-les-Pins, this flat is situated in a well-maintained residence featuring several lifts, a collective gas heating system, two street access points, and the presence of a caretaker.

Located on the 1st floor, this studio-type flat has a north-west exposure and offers a surface area of approximately 28.38 m² (Carrez law). It comprises an entrance hall, a living room with built-in cupboards, a separate unfitted kitchen with cupboard, and a shower room with toilet. The living room and kitchen enjoy an urban view. A cellar adds to the comfort of this property.

This spacious studio combines charm and everyday practicality. It is equipped with double windows in the living room and kitchen, electric shutters in the living room, manual shutters in the kitchen, reversible air conditioning in the living room, and radiators with individual meters in each room.

The flat offers great potential and is an excellent base for a renovation project to your taste. Please note: the plumbing has already been recently redone.






